



Participation, Release and Indemnity Form - *A Forest for Australia* and Altona treatment plant tour

Important information

All persons attending the tour of *A Forest for Australia* land art installation and Greater Western Water Altona Treatment Plant site must agree to these conditions and sign this form upon arrival at the event.

Greater Western Water reserves the right to refuse entry or require departure from the site if any of the conditions of participation are not met. In addition, if safety is in any way compromised or at risk due to unforeseen circumstances including weather, the event may be cancelled.

Please be aware that attendees will need to be comfortable to be mobile for **90 minutes**.

Any attendees with mobility issues will be invited to enjoy the first forest spiral, due to the remaining sites having uneven surfaces.

Acknowledgement of Participation, Release and Indemnity

1. I will be attending the tour of *A Forest for Australia* and Greater Western Water Altona Treatment Plant site (**Event**).
2. I acknowledge I am fully aware of and accept all risks involved in my participation in the Event and to the maximum extent permitted by law, I:
 - (a) release and forever discharge Greater Western Water and Hobsons Bay City Council, their officers, servants and agents and each of them; and
 - (b) agree to indemnify and keep indemnified from and against all actions, losses, costs, claims, charges, expenses, penalties, demands and damages and other liabilities whatsoever which may be brought or made or claimed against them, or any of them,arising out of or in any way related to the Event and my participation in it.

Conditions of entry:

3. I acknowledge and agree to the following conditions of entry.
 - a) Directions must be followed at all times.
 - b) Access permitted to pre-registered attendees only.
 - c) Permitted attendees **MUST** wear appropriate attire: long pants and long sleeve tops, flat heeled and enclosed shoes.
 - d) High visibility vest and safety glasses will be supplied and must be worn at all times during the tour.
 - e) Children below the age of 12 years will not be permitted to attend tours.
 - f) Permitted children are required to be supervised by an adult guardian with a maximum of one child per guardian.
 - g) Attendees must be free from the effects of drugs and alcohol.
 - h) Smoking or vaping is not permitted on site.
 - i) Vehicles must comply with all signage, posted speed limit of 20km/h and park in specified area.
 - j) No filming during the tour is permitted. Photographs of ***A Forest for Australia*** (Sections A and B) is permitted.
